DESCRIPTION

BERRAKURE P is a high solid, polymer emulsion specifically formulated for the curing of concrete. The specially selected polymers contained in **BERRAKURE P** produce a fast drying membrane without the potential compatibility problems that can occur with wax or solvent based coatings.

BERRAKURE P contains a fugitive dye (white). The dried coating becomes clear within a few hours of application.

APPLICATION

Apply **BERRAKURE P** to the concrete as soon as the bleed water has gone and the concrete has hardened sufficiently so as not to be marked by the application process.

Apply **BERRAKURE P** undiluted at arate of between 5 and 8m2 per litre. Best applied by spray, however, may also be applied by brush, roller or broom.

NOTE: Ensure all equipment is thoroughly cleaned in water.
